### "Untangled"

Full of shame and remorse, she just wanted everyone to go away. Turns out all she needed was a loving hand

I crawled my way into my first meeting of AA. I was off the street and defeated utterly. I was 24 years old. I looked terrible and smelled even worse. I was jittery, lost and had an attitude of defiance that hid a wall of shame that was 10 feet thick and 100 feet tall. I was dressed highly inappropriately as well. Years later, friends who saw me that first day said I was wearing the tube top of justice and the hot pants of freedom.

I judged everyone I saw immediately and harshly just to beat them to the punch. I thought if I hated you first, then somehow I would be the winner. My bravado was the only survival skill I had left. I sat in the back of the room with my head down for a week on what some members referred to as "death row." I was arrogant and judgmental, but too scared to leave and too afraid to go back out on the streets.

I hated everyone in my life. And I found I hated women most of all, those clear-eyed, perfect, perfumed, clean women. If they discovered who I was, where I'd been, what I had done, the rejection would kill me.

One woman in particular bugged me most. She was all of five feet tall with a quiet calm that rattled me. I was curious about her because she was so kind and spoke with such compassion and confidence. But because she was the lady that I knew I could never be, I had no choice but to hate her.

One day, after a week of slithering in and slipping out the back door, coming in late and leaving early, that diminutive giant of a woman walked across the room as I sat slumped in a chair. She bent down and got in my face, not aggressively, but with a voice of love I had never heard before. With quiet assurance she simply stated, "Honey, I'm gonna brush your hair."

Without my permission, she pulled the chair away from the wall, stood behind me and touched me with a gentleness I had never known. As she brushed out my tangled, dirty hair, I realized I had no defense to this random act of kindness. I did something I thought I would never do. I began to cry. When the tears came, I let them fall. I had no box to put that amount of emotion in.

Years of shame, remorse and darkness poured from me that day. With each tear that fell, I could feel a chunk of the wall I had built hitting the floor. I will never forget that day or the feelings that came alive in me to heal my hurts.

That woman took a chance and loved a stranger. I know God whispered to her to love the unlovable. Although we may make judgments, we never let that stop us from extending the loving hand of AA to those in need of help. For me, on that beautiful day, that hand was holding a brush. -- "Shoeless" M. RUNNING THE UNIVERSE

I was the general manager of the universe. At least that was my self-proclaimed title. I didn't realize that was what I was acting like, but everyone else did. If you didn't take my advice I'd get really upset and some form of my wrath would descend upon you. And all that time I was being so nice (I thought). I'd be all sweet and light but would turn on you in a heartbeat. That was my alcoholism. That was me prior to September 8, 1994.

I've been humbled many times in sobriety. I once lost a job because I had not provided the proper paperwork (in the medical profession, that's illegal). I've been told, "Rozanne, it's not called Rozanne Anonymous, stop trying to change everything to be about you." I've had sponsees come and go, teaching me about the magic of AA: It's not about me.

How am I carrying the message to other alcoholics? Am I doing everything I can? Does the woman sitting beside me at work have a problem? Can I be an example of the Big Book to her?

Today, 20 years after giving up that general manager position, I am still continually reminded that I must give it away to keep it. I must remember, every day, that my main purpose in life is to stay sober and help others.

Life is good. The other day, I was having lunch with a coworker and she asked me how I could be so happy all the time? I pointed to the heavens. I said nothing. I just pointed and smiled. -- Anonymous

When she took out her sandwich, he got to see what a special worker she was

Several years before I stopped drinking for good, I wanted to learn about the program I heard could fix alcoholics. After looking up the address of the local AA office in the phone book, I decided to pay them a visit. Their office was located in a downtown building I was familiar with, so I got in my car, took a few swigs from my bottle and was on my way.

The office door simply said "AA". Inside there was a tiny lady sitting at a corner desk typing. I asked her for information about AA. She got up and showed me the literature displays and explained how to use the directory to find an AA meeting. I shuffled around for a while, glanced at a few pamphlets and then asked her why anyone would ever go to AA.

"Wait a minute," she said. She immediately stopped what she was doing at her desk, put her work away, cleared off an area, brought out a sandwich and started eating. Pointing to a chair, she said, "I'm taking my lunch break now. Why don't you have a seat." I thought she was a little off her rocker. Then she started telling me her story and how AA had saved her life.

I had no idea at the time, but that's Tradition Eight. This kind, wonderful, non-professional alcoholic service worker was experienced enough to separate her professional work from her Twelfth Step work.

She never knew it until much later, but the short time I spent with this lady was the reason I developed the courage to come into AA years later. I don't remember the details of her story, but I remember the feeling of hope and recovery she gave me that day.

So whenever I think about this Tradition, I'll always remember the gift of grace I was given by a lady I'd never met, sitting in a place I'd never been, who was practicing not only the Traditions but the principles of AA to the fullest. --Alex M. Louisville, Kentucky

#### THE ENDLESS GLASS OF WINE

Close call at a nearby eatery

I was standing beside the counter at a local restaurant with my laminated claim number in hand. I glanced around the room and noticed that several of the other waiting patrons were holding onto wine glasses in addition to their claim numbers. My attention was drawn to the server behind the counter who asked one of the customers, "Would you like to upgrade to the endless glass for \$7?"

An endless glass? Really? How come I didn't know about this place when I was drinking? Suddenly, it seemed that everyone around me was sipping on wine. I could see red and white liquid flowing everywhere. On top of it, I heard the server behind the counter ask the next person if they would like cabernet or merlot. Cabernet sauvignon used to be my favorite! I can still recall the scent of the complex pungent tannins. I began to imagine savoring the peppery, full-bodied black-cherry liquid.

My mind then began to conjure up a story of what it would have been like to know about this restaurant back then. Why, it's just a few blocks from my home! I could have walked over and consumed glass after endless glass. I could have even walked back home with nary a concern of being picked up for a DUI.

But tonight, because I have three years of sobriety, I snapped out of it. I remembered what it was like when alcohol took over my brain. How infuriating it was when my words came out slurred. How worry would set in later about how I'd made a fool of myself. I remembered how hard I worked during my drinking years to act "as if" I was sober. It was exhausting.

Standing here at the counter, waiting for my meal, I realized what a blessing it was that I'm in AA. Instead of feeling self-pity because I can't drink like others, I looked around the room at everyone enjoying their wine and became deeply, reverently grateful for my sobriety. My desire to drink has been replaced with freedom. --Jean C. Edina, Minnesota
